I. OPEN REGULAR NORTHSHORE MEETING

1.1 Roll Call

Chair Rick Webster called the meeting to order at 5:00 PM.

3.1 Commissioner Verlinda moved to add Item 5.4 Merger Discussion to the agenda. Commissioner Ellis seconded. The motion passed 3-2. Commissioners Ellis, Pratt, and Verlinda, voted to approve the motion. Commissioners Maehren and Webster voted to oppose the motion.

Commissioner Pratt moved to approve the agenda as amended. Commissioner Maehren seconded. The motion passed unanimously.

- Commissioner Verlinda requested information about the cost, timing, and content of the mailer sent to residents, and if the Board is following the RCW for fair and objective information.
- Commissioner Maehren responded that the mailer cost was included in the contract with Liz Loomis and will be sent to every resident in the district, per State law. The Communication sub-committee, along with the Fire Chief, reviewed and approved the content.
- Matt Paxton clarified there is a State election law that prohibits the District from using its resources to advocate for or against any ballot measure, however there are exceptions including informing the public with fair and objective information. Mr. Paxton recommended further discussion be done in Executive session due to potential litigation.
- O Commissioner Pratt read a prepared statement regarding the merger. The statement was added to the meeting's related documents.

Fire Chief's Report

Submitted by Chief Ahearn April 6, 2021

Operations Report:

Our two new were placed into service and have been operating very well. Minor punch list items are being addressed through BC Tagart.

We will be hosting a vaccination clinic at Station 51 on April 13, 2021 for our residents living in our Mobile Home communities. We anticipate vaccinating approx. 70 NSFD citizens.

Our crews are attending tactics training put on by the NKCTC along with Human resource and evaluation training taught by our very own HR director Shannon Moore.

Completed our PSERN or Puget Sound Emergency Radio Network submission in preparation for new radios towards the end of 2021.

DC McDonald attended a 3-hour community forum on March 31 from 1700-2000. He presented the districts presentation on merging with WF-R.

3 of the 4 shifts and including DC McDonald have completed the orientation on our new hose. C shift will have their training completed shortly. There was significant hands-on manipulation of the hose and nozzles. Great class taught by FF Jayden Petro.

Training:

North King County Training Consortium (NKCTC):

- NKCTC administered the midterm for a Northshore probationary firefighter.
- NKCTC will administer a final written and practical exam for a Northshore probationary firefighter. This will be the first final exam process across the participating agencies.
- NKCTC completed the Multi-Company Evolutions at Station 51. The drill was built on February's North End Drill of Rapid Intervention Crew deployment in creating a mayday drill for two trapped firefighters. The drill was coordinated to include NORCOM for dispatching the units assigned to each specific evolution.
- The Training Officers have been collaborating on the framework of a Fire Academy for 2021.
- The Training Officers delivered Tactical Training for Company Officers and Battalion Chiefs with a focus on repetitions of initial radio reports, follow-up radio reports, and transfers of command to the incoming Battalion Chief.
- NKCTC had a Leadership, Education, and Development class for crews delivered by the Human Resources representatives from each of the participating agencies on April 1, 2, 5, and 6.

- 13 sprinkler inspections
- 12 code enforcement inspections
- · Final inspection at The Lodge hood system
- · Tour of the Lodge with Carl Lunak
- · Installed CodePAL (Inspection program) onto Jen's computer
- · WSFAM webinar: Mobile Food Preparation Vehicles
- · Compiled 2nd Quarter inspections for the crews (Jen entering data)
- · Pulled statistics & reports for Annual Report

NEMCO:

- EM Lunak and FI Booth along with some NEMCo volunteers shot a few video clips to present to CERT students in upcoming classes including one of fire extinguisher use and basic search and rescue techniques.
- NEMCo volunteers and EM Lunak met with Bastyr University to discuss supporting their CERT program and utilizing their facility for future classes
- EM Lunak completed a review of the draft Emergency Response Plan for Northshore Utility District that is due in June of 2021

Formal Statement for Commissioner reports to be read at Commissioner meeting on April 6, 2021

It's clear from my record in previous meetings that our current course for consolidation isn't my preferred course. This is due primarily to its focus on cost savings at the expense of service level improvements. However, I agreed to support our current course because I felt that it did provide some measure of operational efficiencies, the potential for service level improvements and could lead to a framework for broader regional mergers.

I want the citizens of Kenmore and Lake Forest Park, the Northshore Board, Northshore fire admin and firefighters to know that I continue to feel that consolidation provides the best opportunity for improved service levels and operational efficiencies. Please also know that moving forward I will continue to work for and support consolidation that seeks these ends. But, effective consolidation requires the support of all vested parties and unfortunately our current endeavor not only lacks support from our firefighters; it has their unanimous and robust opposition. The failure to gain the firefighters support is a failure of communication and leadership. As the vice chair of this board and member of committees dedicated to promoting this merger a measure of this failure is mine. As a result, I feel it inappropriate for me to continue to push this merger forward and have to formally withdraw my support. My hope is that from this likely failed attempt we will learn, grow and be able to move forward with clarity and a better understanding of how to successfully merge the North King County agencies.
