MINUTES

REGULAR MEETING BOARD OF COMMISSIONERS

I. OPENING OF MEETING

Commissioner Carolyn Armanini called the meeting to order at 5:00 PM.

Persons in attendance were Commissioners Carolyn Armanini, Don Ellis, Dave Maehren, and Kae Peterson. Also present was Fire Chief Jim Torpin, Legal Counsel Kinnon Williams, Board Secretary Kate Hansen, and a member of the public. Absent was Commissioner Eric Adman.

II. APPROVAL OF THE AGENDA

Commissioner Maehren moved to approve the agenda as presented. Commissioner Ellis seconded. Motion passed, all in favor.

4.1 <u>2016 Second Quarter Financial Report</u>

Chief Torpin reported that there is nothing unusual in the second quarter financials. The checks and balances in the current accounting system proved comprehensive in catching a double posting of a deposit that has been corrected.

- Commissioner Maehren noted that nearly 100% of the funds budgeted for Puget Sound Energy at Station 57 had been expended. Chief Torpin indicated he would look into it and report back.

Commissioners Maehren and Adman have met with Chief Torpin regarding the draft Strategic Plan. The committee will come back to the board for further input on proposed amendments.

VI. FIRE CHIEF'S REPORT

No written report was submitted. Chief Torpin reported:

- O There has been an upgrade to the Station 57 Apparatus Bay lighting. The upgrade included the replacement of the florescent lighting with more efficient LED bulbs and rewiring of some of the lights to stay on at all times to allow better visibility when crews return from calls at night.
- The trees at Station 57 have been removed. A replanting plan will be developed and monies will be paid to the city's tree fund for any trees that are not replanted. The area will be maintained to prevent future problems with undesirable tree infestation.
- Multiple upgrades have taken place or are planned for Station 57. The 2016 projects have been completed and the next project is a remodel of the bathrooms which will be done in early 2017.
