MINUTES

September 2, 2014

REGULAR MEETING BOARD OF COMMISSIONERS

I. OPENING OF MEETING

The September 2, 2014, regular meeting of the Board of Commissioners of King County Fire Protection District No. 16 was held at District Headquarters located at 7220 NE 181st Street, Kenmore, King County, Washington. The Chair, Eric Adman called the meeting to order at 1700 hours. Persons in attendance, in addition to the Chair, were Commissioners Carolyn Armanini and Ron Gehrke. Also present were Secretary Andrea McDaniel and Legal Counsel Kinnon Williams. Commissioner Maehren arrived at 1712 hours and Commissioner Kae Peterson was absent.

A brief discussion ensued regarding the need to perform a salary survey for the fire chief position. Following the discussion Commissioner Armanini moved to have Human Resource Specialist Shannon Moore complete a salary survey for the Fire Chief position by October 21. The motion was seconded by Commissioner Gehrke and passed with a vote of 3 to 0. The Board requested that Human Resource Specialist Moore provide an overview of the salary survey process and potential comps for the Fire Chief's position at the next regularly scheduled meeting of September 16.

Finance Specialist Andrea McDaniel provided a brief report on recent and past issues with the Departments current credit card vendor and indicated the Department would be changing to a new vendor next month.
