MINUTES

December 27, 2018

SPECIAL MEETING BOARD OF COMMISSIONERS

at Northshore Fire Department's Headquarters Station 51

I. OPENING OF MEETING

Chair Dave Maehren called the meeting to order at 10:14AM.

Persons in attendance were Commissioners Suzanne Greathouse, Dave Maehren, and Ron Gehrke. Also present was Fire Chief Jim Torpin, Board Secretary Kate Hansen, and one member of the public. Absent were Commissioners Don Ellis and Rick Verlinda.

II. PUBLIC COMMENT

Lake Forest Park resident Mike Dee addressed the Commissioners with the following comments:
